The Sunday Markets at Sapphire have started up again as of the 9<sup>th</sup> April 2017, also there is a Saturday Markets at the Rubyvale Flats which started on the 8<sup>th</sup> April 2017

#### **SECRETARY'S REPORT:**

I hope you are all well, and enjoying life whether it be on our beautiful Gemfields or the Maldives! In this issue, I need to bring to your attention a few important issues that have arisen and what your Committee have done in response.

In July 2015 when the QSMA were granted its Permit to Occupy at Lot 237 On Plan AP21061 we were lead to believe that we could build a structure on this land for our meetings/Office, with power and water attached necessary for our needs as we blossomed into an organisation that could, as a mining group, have a real impact with all Government bodies, Tourism and Community as the miners input for our areas future needs going forward.

Meetings your Executive had with Local Government, Local Members of Parliament, DNRM and the Local Police were in favour of our vision and assured us of their full support. We then applied for Grant Applications of which all were unsuccessful mainly due to the uncertain tenure of the Permit to Occupy. We addressed the topic of converting the Permit to Freehold with the relevant authorities, the then Central Highlands Regional Council Mayor and CEO both were in full support should this avenue be followed by the QSMA. After much investigation and following through with this action, we were finally informed by DNRM that under the current Permit, we would be unable to build a permanent structure on the land under its current tenure and upgrading the tenure had enormous risk and financial expense attached, which included a Native Title agreement under the Lands Act, this process was to be far more complex than the Negotiations under the Mining Act we are currently involved in. Therefore, the land was now not suitable for the QSMA for its original purpose. After the committee carefully considered all avenues a motion was put forward and the committee agreed to surrender the Permit to Occupy, this was completed on 21<sup>st</sup> December 2016.

The Waste Management Charges applied by the CHRC continue to be discussed at the CRG meetings with the fee under consideration for review in the lead up to the forthcoming CHRC budget. We will keep you informed on any progress on this issue as soon as any information comes to hand.

Several members have approached me on the substantial increases in Financial Assurance (FA) the DNRM are enforcing on many renewals. I have been led to believe that due to the 10 year tenure terms the Department are looking at your tenure infrastructure and disturbance as to how much this would cost the Department (should you abandon your claim) to restore after the 10 year term expired. Remember, you do have the ability to have your cash FA as a fixed deposit in your own bank, insuring you get interest on your own money.

I have also had members complaining on the various notices the Department has sent out, these notices are compliance notices, where on inspection by the Department certain conditions were vastly lacking. The main notices I have seen were for work compliance, and keeping your claim tidy.

Note: (1) (Untidy Claims) An untidy claim will attract the attention of the Department, and it is a part of your Obligation History Statement declaration of which you signed on your renewal that you must keep your claim tidy. A good idea before you leave your claim after Winter is to store your mining equipment in a safe place, this will minimise any theft and your equipment will not encounter any of the severe summer storms that are the norm in our area.

Note :(2) (Work Compliance) Taking a photo before starting work on any area of your claim and after rehabilitation will help, it is also beneficial to keep a work diary so you have proof of compliance assuring notices of this nature are never an issue for you.

Please feel free to let us know of any problems you may have or if you have any suggestions in improving your organisation.

#### PRESIDENTS REPORT/NATIVE TITLE REPORT:

Welcome to all members, old hands and new. Well here it is, April and soon it will be Christmas before we know it, my times flies. As you may or may not know, the Gemfields has received some good rainfall of late which has been very much appreciated.

#### MY STEPPING DOWN AS PRESIDENT:

Due to a medical ailment that requires surgery and a long convalescence, I have made the decision to step down as President of the QSMA. This is not a decision that has been made lightly, however there comes a time when a person has to put themselves above all else and this is what I have done.

Your Association has a strong, honest Committee that has always worked for the best interest of its members.

It disappoints me to say that there are two members who appear to be hell bent on bringing not only this Committee into disrepute, but your Association also. The accusations and lies told by this member and the other member acting in concert with him are absolutely despicable and without grounds.

As Native Title Co-Ordinator I can assure you, the Members, that I was less than impressed that this particular member was trying to interfere with the negotiations for Native Title. It should not be underestimated the number of hours that myself and the other three members of the negotiation team have and are still yet to put into Native Title. (More on this next)

No Association should have to put up with people of this ilk as members, as they have shown a blatant disregard for the best interests of you, their fellow members.

#### **NATIVE TITLE NEGOTIATIONS:**

As you may have heard by now, there has been a spanner thrown into the works of Native Title. The issue is very complex and will be hard to explain in a couple of paragraphs so I will try to be as brief as I can and keep it in simple English.

In 2010, the Western Australian Court handed down what was known as the Bygraves Decision. What this meant was, it only required the majority of the Native Title Party members to sign any documents and this decision was then used as the benchmark for all negotiations.

In 2016, this decision was challenged by someone from Western Australia (it appears most Native Title challenges come from WA). On the  $2^{nd}$  of February 2017, the full bench of the Federal Court ruled that the Bygraves Decision was invalid which then put all agreements in limbo, (this became the McGlade decision). On the  $16^{th}$  February 2017, the Federal Government passed emergency legislation to rectify only half of the problem. This forgotten half (s) 31 Deed, which makes your agreement with the Native Title Claimants legal and binding, is now in the stages of being sorted out. All parties are now waiting for the State to make its position known.

I would like to assure all members that Native Title does not have to be renegotiated, this is all done. As soon as the State has made its position clear, it will be full steam ahead. This situation that we are now faced with is not the fault of the State, the Native Title Parties or the QSMA. It happened as we were just about to cross the finish line. This situation will be resolved sooner rather than later.

#### FINALE:

I have enjoyed my time as President, the people that I have worked with and at times debated vigorously with (this is what makes a strong Committee) are all dedicated to trying to bring about better conditions for Small Miners, we admit not always with success, however that being said at least you have a voice and an Association will only be as strong as the support it receives from its members. I will remain on the Committee and continue in my role as Native Title Co-Ordinator.

In closing I wish you all good health and many finds.
