SECRETARY'S REPORT:

The QSMA have sent and received several Ministerial Letters, topics include encroachment on the rights of Sapphire Miners in Central Queensland Gemfields, of particular concern is the layer constraints within the various Acts that govern our industry, the inconsistency's within those Acts and the need to strengthen the protections afforded by the Mineral Resources Act 1989 & Fossicking Act 1994. Your committee are requesting a Review of the Mineral Resources Act, Land Act and Vegetation Management Act to recognise Mining /Fossicking DFL Areas as a legitimate and priority land use. A QSMA meeting with the Minister Anthony Lynham has been requested by our Local Member and Mines Shadow Minister Dale Last to further discuss the importance of these issues.

An invitation was sent to QSMA from Policy Advisor Mark Simpson, Regulatory, Support & Performance, Mineral & Energy Resources, seeking feedback on the review of the Mining Fossicking Regulations 2009 that is about to commence. These regulations are required to be remade every 10 years in order to maintain their relevance to the community. The QSMA are viewed by the Department as stakeholders in this process. Your committee undertook this assignment with a deadline of 31st May, this has now been lodged. Note that the review was limited to only issues pertaining to the Fossicking Regulations 2009 therefore the concerns QSMA have re: The Fossicking Act 1994, unfortunately are not relevant to this submission.

A New Bio Security and Other Legislation amendment Regulation 2019 was made 24th April 2019 which will have dire consequences for Miners, Tourists and fossickers to our area. This is now Section 41 A and 41B of the Biosecurity Regulation 2016. https://www.legislation.qld.gov.au/view/pdf/asmade/sl-2019-0056. In a nut shell, If a landholder draws up a Bio Security Plan (*he can devise this as he wishes*) with the stated signage at his property's entry that he has a bio security Plan, you must adhere to every requirement he has devised under that plan.

This is one example a Landholder has already drawn up: Every person entering the Property will need to have their vehicles *certified weed free* (this cost approx. \$250.00). Those who enter (and on each & every entry) will have their clothes, shoes and belongings searched by the Landholder or their agent. If your *certified weed free vehicle* does not pass inspection to the Landholders personal approval, he may clean your vehicle at his "Washdown" area on his farm *and charge you for it.* If your clothes do not pass his inspection, he will be able to refuse entry. If you pass his inspection and are allowed to enter the area, the same process will apply on your exit. This is for all persons entering and exiting the area, weather you are a Miner, Explorer, Visitor/Fossicker/Tourist. This example is currently in action on a "dry land cattle farm" not a feed lot or other intense farming. Note: This "Bio Security Plan" consisting of 175 pages can be viewed by members on application. It is obvious many Landholders can and will push this barrow for all it's worth to keep the Miner/Explorer or Tourist/Fossicker out, in effect locking up the States Minerals. This Section 41 has huge ramifications on our DFL areas and all Mining/Exploration in Queensland if Bio Security Plans are installed. Your committee are currently in negotiations with Bio Security Queensland, the Department and the Minister on this matter.

This regulation was rushed through by our current State Government to deter the "vegan activists" trespassing on farms, but this has had a much wider repercussion on those with legal reasons for entry onto property's with Mining/Fossicking and Exploration interests.

QSMA Committee had a meeting with Noel Towers (Inspector of Mines) and Kate Du Preez (Mining Commissioner) on 22nd May. This visit was to familiarize her with Gemfields type of operations and feedback with the proposed Gem Miners Handbook being prepared by DNR & M in liaison with QSMA Committee. They are also looking for approximately 6 Miners to undertake an air sampling during their daily operations for tests on Gemfields miners for Respirable Crystalline Silica Monitoring (RCS). So far, we have three miners willing to undertake this testing. If you would like to be involved in this testing process please ring Noel Towers on 0427465137 or e-mail noel.towers@dnrme.qld.gov.au.

We have had communications with the Acting Manager Assessment: Small Scale Mining Hub in Rockhampton re Information sessions for Gemfields Miners, they are currently proposing a plan to have teams from Myminesonline, the Department of Environment & Science (DES) and Safety and Health in attendance around Gemfest time, they will also be conducting these sessions for Winton & Quilpie. Once we have a set time and date schedule from them, we will keep you informed. Please make sure you have a current e-mail address for this. Notices will also be put up on the QSMA Notice Boards.

Now for the topic of my proposed resignation at the end of this term. Due to the overwhelming support by numerous members and some committee for my continuance as Secretary, I have re thought my position and in the interest of the QSMA, its members and the melting pot of issues that we are currently dealing with and some on the cusp of bringing to completion, it would be foolish to try and bring a new Secretary to this position who has no intimate knowledge of the issues at foot or the requirements needed to further these issues, therefore I have decided to stand for one more term only, should this be the wish of the members.

Please find below a few of the requirements necessary for an incoming Secretary:

Due to the fast pace of changes to Policy and Legislation in the Queensland mining industry and other Acts that affect our industry on the Gemfields, any incoming Secretary must have the time and knowledge to adhere to timeframes and procedural steps needed for various submissions required by the QSMA as stakeholders in aspects of these changes, therefore the Secretary must have a working knowledge of the various Acts: MRA 1989,MOWLA Act 2018, MERCP Act 2014, Biosecurity Act 2014, Native Title Act 1993 and The Cultural Heritage Act 2003. Have a firm understanding of the Mining history of the Gemfields and be able to liaise with the relevant Departmental Officers in all Statutory Departments. The secretary will need to deal with numerous phone calls from members requiring information or sorting out their paperwork with regards to various problems that need answering or explanation if they do not understand the directions given to them by the Department.

The Secretary must be able to draft letters and respond to correspondence from the Ministry, Policy advisors and various Government bodies as per the Committees direction. Take minutes of each meeting. Attend all Committee meetings where possible and General meeting briefings. Prepare Committee update for each Newsletter and filing of correspondence. The Membership register is currently being kept updated by the Treasurer/Assistant Secretary who also compiles and edits the Newsletter for distribution.

Regarding My Mines On Line renewals and applications. I am unable to continue to lodge these for members as it takes up a considerable amount of my time and given the number of issues we are dealing with as a committee, I just cant find enough hours in a day to juggle everything, with running a business at the same time.
